Continuing Business

Budget Report – Robyn

We started the year with a balance of \$1047.50 and our balance as of June 30, 2010 is \$855.05.

We took in \$871.98 from the plant sales and our expenses were \$659.30 to Skagit Valley for the flowers and \$75 refunds to 4 people who did not receive the flower bowls as Skagit Valley ran out but did not give us any forewarning. We netted \$137.68.

An invoice totaling \$194.45 came in from Facilities for custodial use from the Spring Retreat.

Fleeces/Jackets – Lisa

The group discussed selling fleeces/jackets and the consensus is yes, we want to sell jackets. We need to have a chair and would like to have samples here to show people what they will look like. It was suggested we have the order placed in time to have the jackets for the beginning of fall quarter.

New Business

August BBQ – Lisa

Lisa asked the group if they would like to see the GSO host another barbeque in August and everyone liked the idea. Last year the barbeque was held on Wednesday, August 26th and the turnout was very good. We sold out with approximately 80 meals served.

Since that day and date worked well last year, we will keep in on a Wednesday and set August 25th 12-1:30pm. We will need tables set up, permission to use the outside area in front of the commons and advertise. Last year we charged \$5/hot dog meal and \$6/hamburger meal and used Cascade Mountain Grilling as the vendor. We want to use them again and hope to keep the prices the same for this year. Music would be nice to add.

Action Item: Lisa and Elizabeth will purchase chips, cookies, Country Time lemonade, and any needed supplies from Costco.

Lisa will also ask Hillary U, their student worked if should print up tickets and flyers again this year. We will start advertising August 2nd and give Cascade Mountain Grilling a headcount by August 19th.

Poinsettia Sales – Lisa

In previous years, the GSO has sold poinsettias for the holidays and Lisa asked about doing them this year. We can take orders at the fall activity and have them delivered in time for the holiday party. We need someone to chair this project if it is to happen.

Action Item: Robyn will find out from Lorrie Cain if Skagit Valley supplies poinsettias and what they charge.

Pancake Breakfast

The discussion moved to the fall activities. Everyone enjoyed the pancake breakfast last year and it was suggested to have it again this year. The date of October 13th was selected and ideas for speakers included asking George Theo, the new Student Life Director. He could give updates on what Student Life is doing. It was also suggested to have Chelsea Knodel with him and talk about student housing.

One thing that was talked about is the fact that events in North Creek are placed on hold until decisions on when to convert it over to a cafeteria are finalized. This affects not only the pancake breakfast but also the holiday party in December.
