Agricultural intervention for food security and HIV health outcomes in Kenya

Despite major advances in care and treatment for those living with HIV, morbidity and mortality among people living with HIV/AIDS (PLHIV) remain unacceptably high in sub-Saharan Africa (SSA), largely due to the parallel challenges of poverty and food insecurity. Food insecurity and poverty contribute to higher morbidity and mortality among PLHIV, and there has been increasing international recognition of the need to address these factors for a successful global response to the HIV epidemic. Yet, to date there have been few studies to systematically evaluate the impact and cost-effectiveness of promising food security interventions on health outcomes among PLHIV. To address these gaps, this project conducts a cluster randomized controlled trial (RCT) of this intervention with the following specific aims: Aim 1: To determine the impact of a multisectoral agricultural intervention among HIV- infected farmers on ART on HIV clinical outcomes. We hypothesize that the intervention will lead to improved viral load suppression (primary outcome) and decreased HIV-related morbidity in the intervention arm

Using Information to Align Services and Link and Retain Men in the HIV Cascade (i-ALARM)

The overall objective of this research is to develop and pilot a cascade-oriented health information management (HIM) intervention that will serve as a platform for aligning clinic and community services and improving men's linkage to and retention in HIV testing, treatment and care. This intervention is being developed through an existing partnership between the NY1 Gugulethu Clinic (or 'NY1 Clinic'), a primary healthcare clinic in Cape Town, and the Men's Wellness Centre (MWC), a project of Sonke Gender Justice, a large South African NGO.

Investigating a masculinities-based approach to increase male acceptance of family planning in Kenya

Male partner resistance to FP has been extensively cited as an obstacle to female contraceptive use in sub-Saharan Africa. Scholars emphasize that gender relations cause men to resist FP and call for the incorporation of male gender norms into sexual and reproductive health programs, however a focus on exploring which specific norms of masculinity constrain men's acceptance of FP has been lacking. We conducted formative research to explore how men perceive FP and how men, women and providers perceive men's role in FP involvement. Drawing on our previous research, we will develop a theoretically informed and community-based intervention that strives to increase male acceptance of female partner FP use. The intervention seeks to shift masculine norms associated with FP resistance in the direction of greater FP approval through FP education, small group workshops, and community campaigns. The findings from this study will inform a future cluster-randomized trial evaluating the impact of a masculinities-based approach to increase male FP acceptance on women's contraceptive prevalence.
