## **A. Executive Summary**

The Campus Design Review Team (CDRT) reports to UW Bothell Chancellor Kristin G. Esterberg and Cascadia College President Eric W. Murray with recommendation and concurrence reports provided through Gowri Shankar, UW Bothell's Vice Chancellor of Planning & Administration, and Meagan Walker, Cascadia College's Vice President of External Relations & Planning. In its seventh year as evolved from the Institutional Project Review Process of the Campus Master Plan, the CDRT completed the site recommendation for a permanent exterior pavilion in the UW Bothell plaza near the entrance of Founders Hall UW1. We will proceed with the preparation and review of the design for the pavilion adjacent to the library building and bring that design back to the CDRT for Master Plan compliance and approvals.

This Annual Report has been prepared to summarize what campus-impacting projects were reviewed within the period, where these endeavors originated from, and the current statuses of the efforts.
